I am a regular user of the Liberty Island Road access to Shag Slough and the Liberty Island Ecological Preserve. Recently signs have been posted indicating this project will remove access to Liberty Island Road and thus access to this segment of the Liberty Island Ecological Preserve. Is this true?

If so, is it possible to complete this project without blocking access to Liberty Island road?

For those of us who kayak or walk in to this area, there isn't any alternative way to access this location.

Would people still be able to walk or bike the Liberty Island road section that runs along Shag Slough?

I visit this location year round and losing access to such a beautiful spot is deeply distressing. Each Spring I take family and friends on kayak tours to see the newborn Swans. I hope there is a way to maintain access. Please let me know the reality of this project. I do support the goal of expanding natural habitat, but preventing access to it would be heartbreaking.
